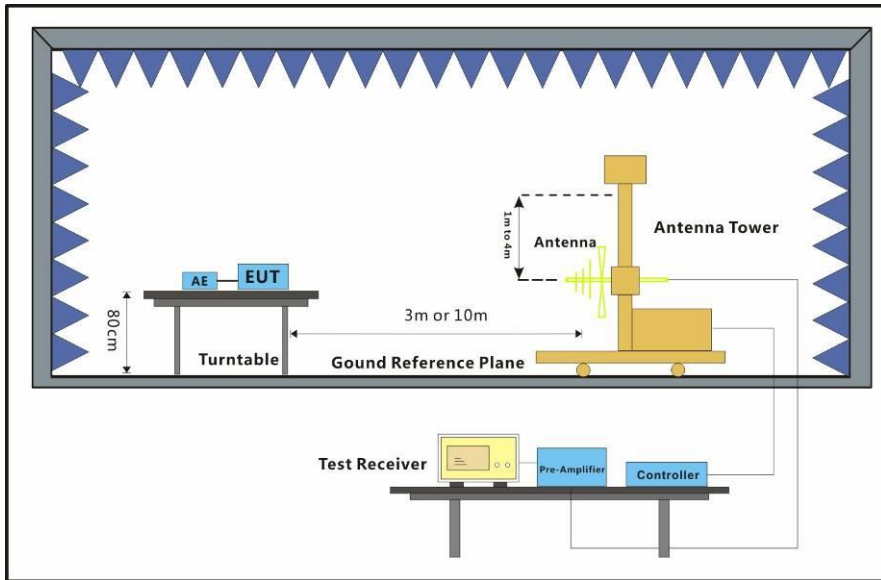

6.1.2 Test Setup Diagram



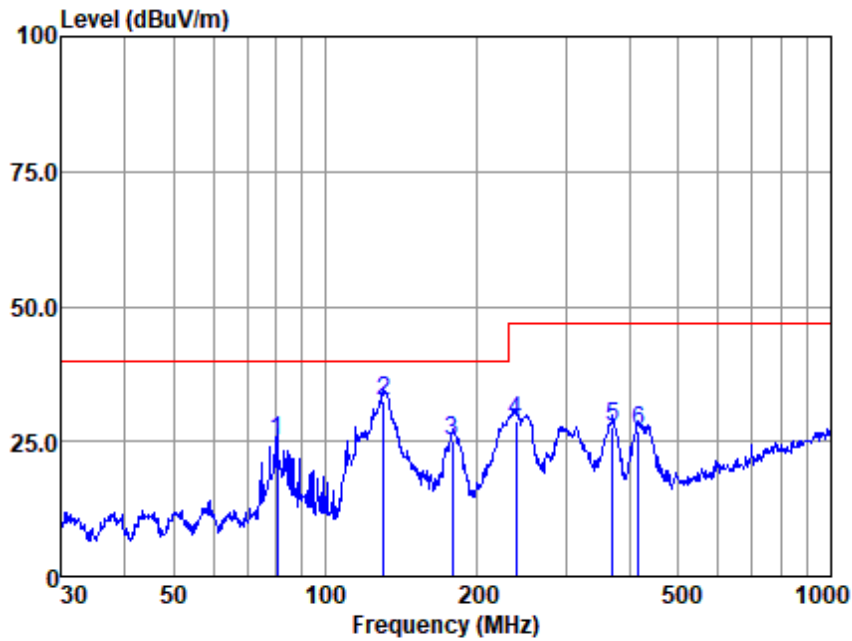
6.1.3 Measurement Data

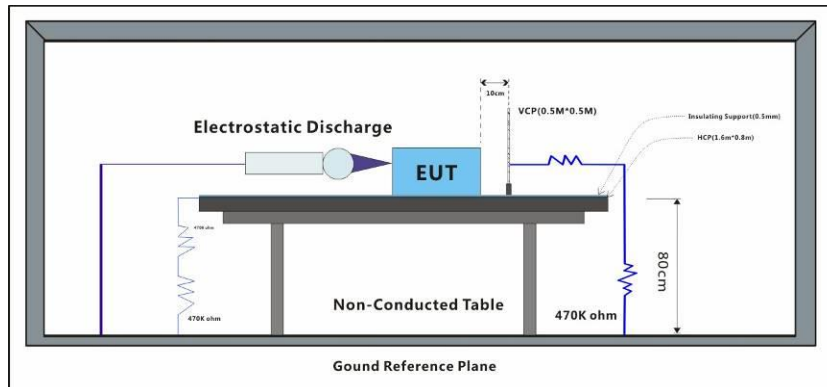

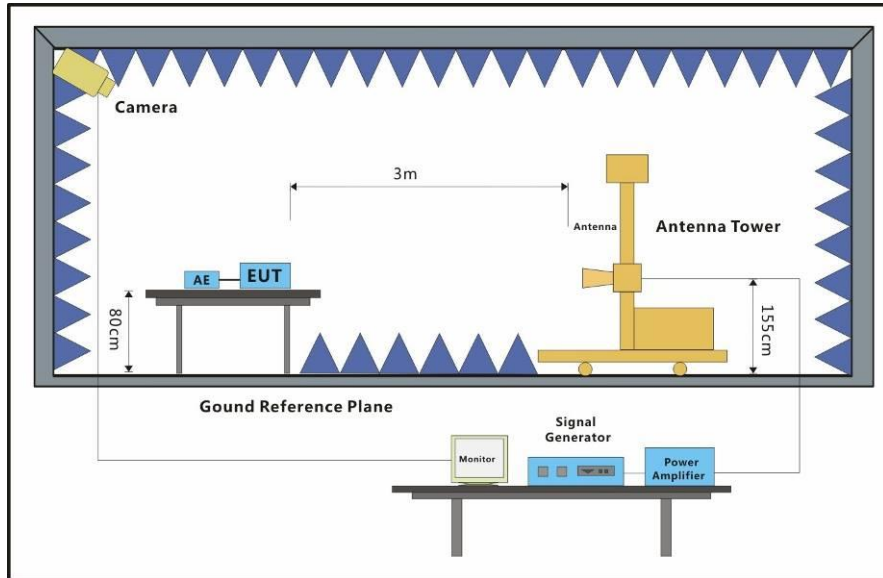

8.1 Radiated Emissions (30MHz-1GHz) Test Setup



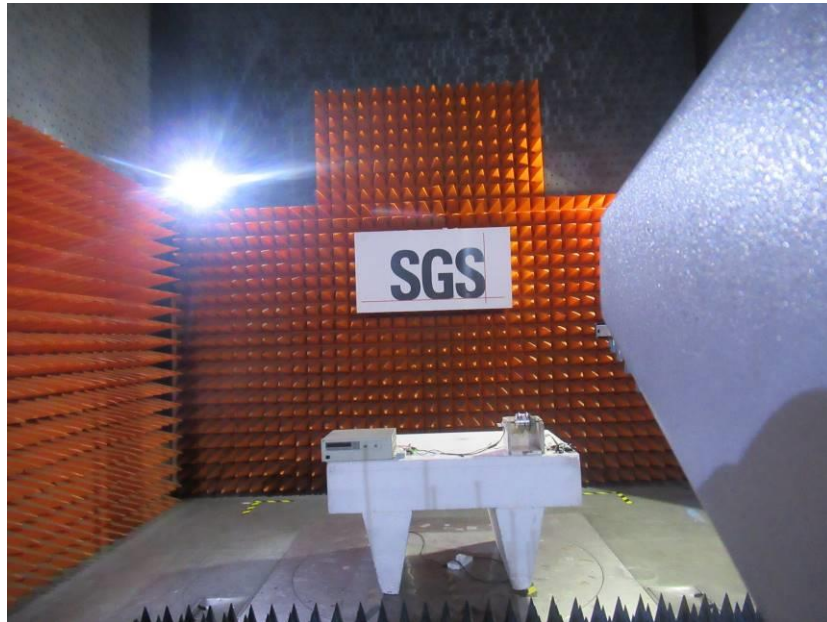
